

ARTICLES OF INCORPORATION  
OF  
TRANSYLVANIA INTERNATIONAL, INC.

I, JACK E. LONDON, being of legal age, do hereby sign these presents for the purpose of becoming a corporation under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE I - NAME

The name of the corporation shall be: TRANSYLVANIA INTERNATIONAL, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business and the objects and purposes to be transacted and carried on are to exercise all of the powers which are now or may hereafter be conferred upon corporations generally by the laws of the State of Florida.

**ARTICLE IX - REGISTERED OFFICE**



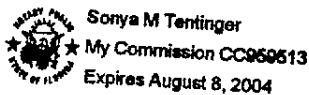


