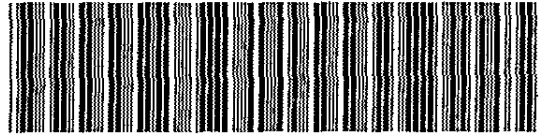

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
PRINCE MANAGEMENT GROUP, INC.

1. The name of the corporation prior to this amendment is **PRINCE MANAGEMENT GROUP, INC.**
2. This amendment changes the name of this corporation to **ALEX SIMON MANAGEMENT, INC.**, and, therefore, old Article I of the corporation's Articles of Incorporation is hereby deleted and new Article I is added and will read as follows:

ARTICLE I – NAME

The name of the corporation shall be **ALEX SIMON MANAGEMENT, INC.**

3. The foregoing amendment was adopted by the Board of Directors of the corporation and by the shareholders of the corporation on May 17, 2004, by a unanimous consent in lieu of a joint meeting of the Board of Directors and the shareholders of the corporation.
