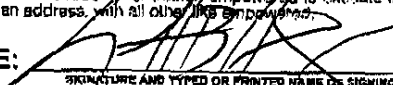

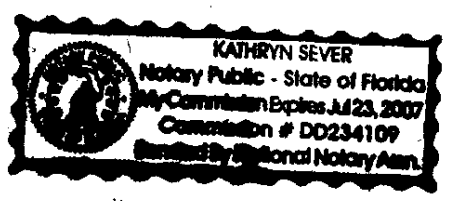
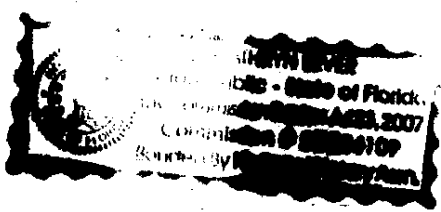
1. Scott B. Hoag is a President of FAMILY HOME FUNDING, INC., a Florida corporation, (hereinafter "Corporation").
