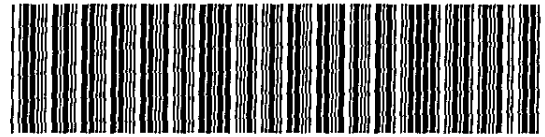

ARTICLES OF INCORPORATION
FOR
WASSCO GLOBAL, INC.

Article I. Name. The name of the corporation shall be **WASSCO GLOBAL, INC.**

Article II. Principal Office. The principal place of business is 29 Yacht Club Drive #302, Bldg D, North Palm Beach FL 33408.

Article III. Purpose. The purpose for which the corporation is organized is to conduct any lawful business for which corporations may be formed under Chapter 607, Florida Corporation Act.
