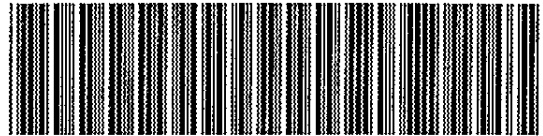

CORPORATE NAME, PRINCIPAL OFFICE
AND MAILING ADDRESS


