ARTICLES OF INCORPORATION OF BIG GATOR SPORTS, INC.

Article I. Name.

The name of this corporation is **BIG GATOR SPORTS, INC.** Its address is 572 North Citrus Avenue, Crystal River, Florida 34428.

Article II. Purpose.

This corporation is organized for the purpose of transacting any or all lawful business.

Article III. Capital Stock.

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

Article IV. Preemptive Rights.
