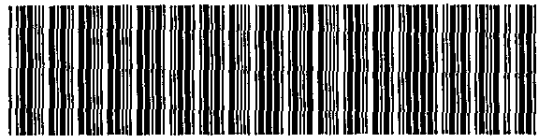

ARTICLES OF INCORPORATION  
OF  
MASTER'S BUILDING MAINTENANCE SERVICES INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is MASTER'S BUILDING MAINTENANCE SERVICES INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the State of Florida and the United States of America. This shall include, but not be limited to: building maintenance.

ARTICLE III - CAPITAL STOCK

ARTICLE IV - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE XI - SUB-CHAPTER S CORPORATION


This corporation may elect to be treated as a Sub-Chapter S Corporation as defined by the Internal Revenue Code.




