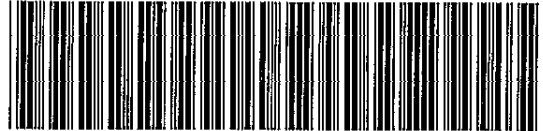

**ARTICLES OF INCORPORATION
OF
MERCEDES MONTEALEGRE, M.D. P.A.**

The undersigned incorporators, being a medical doctor duly licensed and otherwise legally qualified to engage in the practice of medicine within the State of Florida, for the purpose of forming a professional corporation under Chapter 621, Florida Statutes, the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopt the following Articles of Incorporation pursuant to the Chapter 607, FLORIDA STATUTES, the Florida Business Corporation Act:

**Article 1
Name**

The name of the corporation is:

Effective Date and Duration**

This corporation shall exist perpetually commencing as of the date of the filing of these Articles of Incorporation of record by the Florida Department of State.

**Article 3
Purposes**
