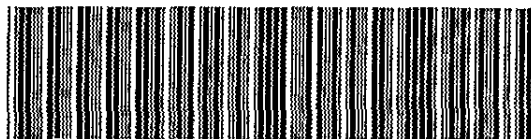

ARTICLE I

NAME

The name of this corporation shall be A & D SUMMER CAMP, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

PURPOSE
