ARTICLES OF INCORPORATION OF MINEAU CONSULTING, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons over the age of eighteen (18) years, competent to contract, hereby present these Articles for the formation of a corporation: under the laws of the State of Florida.

ARTICLE I

The name of the Corporation is: MINEAU CONSULTING, INC.

ARTICLE II NATURE OF BUSINESS

The nature of the business is; assisting criminally charged defendants and their counsel with creating alternative means to sentencing, providing assistance to matters involving probation and parole violators as well as issues involving inmates confined to correctional facilities and any and all other legal purposes permitted under the laws of the State of Florida and of the United States of America.

ARTICLE III STOCK SHARES


