

# ARTICLES OF INCORPORATION OF BAY GLIDE TRAMWAY COMPANY

# ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is The Bay Glide Tramway Company. Its principal office address and business mailing address is 1390 South Dixie Highway, Suite 1203, Coral Gables, Florida 33146.

# ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

# ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

#### ARTICLE IV - CAPITAL STOCK
