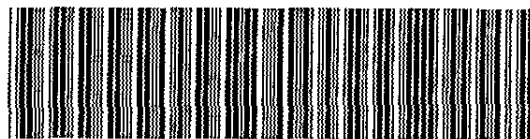

ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, and other laws of the State of Florida.

ARTICLE I. NAME

The name of the professional service corporation is C. Timothy Corcoran, III, P.A.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSE
