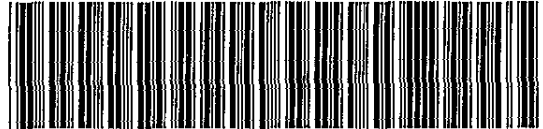



**ARTICLE I. CORPORATE NAME**

The name of this Corporation is Sherri A. Gonsalves, Inc.
