The undersigned subscriber(s) to these Articles of Incorporation, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is: LAKE COUNTRY REAL ESTATE, INC.

ARTICLE II. PURPOSES AND POWERS

The general nature of the business to be transacted by this corporation is: As a small business corporation, to engage in or transact any or all lawful activities or business permitted under the laws of the United States, State of Florida or any other state, country, territory or nation; to improve, manage, operate, sell, buy, mortgage, lease or otherwise acquire or dispose of any property, real or personal and take mortgages and assignments of mortgages upon the same; to make and obtain loans upon real estate, improved or unimproved and upon personal property, giving or taking evidences of indebtedness and securing the payment thereof by mortgage, trust deed, pledge or otherwise; to enter into contracts to buy or sell any property, real or personal; to buy and sell mortgages, trust deeds, contracts and evidence of indebtedness; to purchase or otherwise acquire, for the purpose of holding or disposing of the same, real and personal property of every kind and description, including the goodwill, stock, rights and property of any person, firm,
