Our client, Mr. Christopher Swartz recently discovered that his corporation, Level Zero Communications, Inc. is listed as inactive according to your records. He never received notification about filing the annual report form and payment of the annual fee because the notice was mailed to his old address. Attached is his check for \$300 for the 2004 and 2005 annual fees. We request an abatement of the \$600 reinstatement fee based on the facts and circumstances listed below.

Level Zero Communications, Inc. filed articles of incorporation on June 9, 2003 showing its address as 2550 Lake Debra Drive, Orlando, FL.
