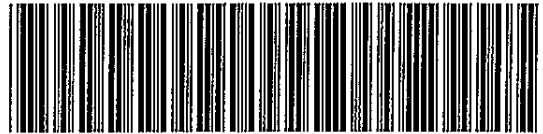

In compliance with the requirements of F.S. Chapter 605, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Salon Iridium, Inc.

ARTICLE II

ARTICLE III





The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


