ARTICLES OF AMENDMENT OF PRECISION ACQUISITION CORPORATION, INC.



I.

The name of the Corporation is PRECISION ACQUISITION CORPORATION, INC. (the "Corporation").

II.

The Articles of Incorporation of the Corporation as heretofore granted by the Department of State of Florida effective on the 6th day of June, 2003 (the "<u>Articles</u>"), are hereby amended to increase the total number of authorized shares of the Corporation's capital stock to 12,000,000 shares, consisting of 11,800,000 shares of Class A Common Stock and 200,000 shares of Class B Common Stock. To effect these changes, Section 1 of Article III of the Articles is hereby deleted in its entirety and is hereby replaced with the following:

"Section 1. <u>Authorized Shares</u>. The total number of shares of capital stock that the Corporation has authority to issue is 12,000,000 shares, consisting of:

- (a) 11,800,000 shares of Class A Common Stock (the "Class A Common"); and
- (b) 200,000 shares of Class B Common Stock (the "Class B Common").

The Class A Common and the Class B Common are hereinafter collectively referred to as the "Common Stock.""

III.

This Amendment was recommended by the Board of Directors of the Corporation to the shareholders of the Corporation and duly approved by holders of a majority of the outstanding shares of the Corporation's Common Stock on the day of October, 2006 in accordance with the provisions of Florida Business Corporation Act Section 607.1003.
