**ARTICLE ONE**

The name of the corporation is Quality Control Services of Northwest Florida, Inc.

**ARTICLE TWO**

The duration of the corporation is perpetual.

**ARTICLE THREE**

The general purposes for which the corporation is organized are:

1. To provide consulting, referrals and home improvements including, but not limited to, carports, patios, pool enclosures and aluminum and vinyl siding projects.
2. To transact in any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

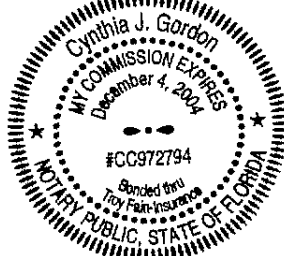


