The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

## ARTICLE ONE

#### NAME

The name of this corporation is GS MARKETING & DISTRIBUTION, INC., and its principal place of business is 19501 Westlake Drive, Miami, FL 33015.

#### ARTICLE TWO

### DURATION

The duration of the corporation is perpetual.

## ARTICLE THREE

#### **PURPOSES**
