Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendments adopted:

Article 1 is hereby amended as follows:

The name of the for-profit corporation of Avian Research Laboratory, Inc., is hereby amended to be a for-profit corporation known as DeTect, Inc.

SECOND: If an amendment provides for an exchange, reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained in the amendment itself, are as follows: NONE.

THIRD: The date of each amendment's adoption shall be effective July 18, 2003.

FOURTH: Adoption of Amendments were approved by the board of directors without shareholder action and shareholder action was not required.
