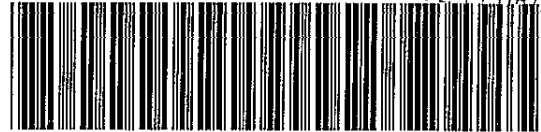



**ARTICLES OF INCORPORATION
OF**

CATHERINE KERN, INC.

ARTICLE I - NAME

The name of this corporation is Catherine Kern, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these articles.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of one (\$1.00) dollar par value common stock, which shall be designated "Common Shares".

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The name and street address of the initial registered office of this corporation is Catherine Kern, 816 ½ Ardmore Road, West Palm Beach, FL 33401.

ARTICLE VI-INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 816 ½ Ardmore Road, West Palm Beach, FL 33401.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the by-laws but shall never be less than one (1). The names and addresses of the initial directors of this corporation are:

ARTICLE X - PREEMPTIVE RIGHTS

ARTICLE XII - AMENDMENT


ARTICLE XIII - AFFILIATED TRANSACTIONS
