The undersigned incorporators to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Florida and hereby adopt the following Articles of Incorporation.

# ARTICLE I - NAME

The name of the corporation shall be MARY'S WHITE GLOVE CLEANING SERVICE, INC.:

# ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- (a) To engage in the general business, including but not limited to cleaning, and any other things necessary in the full and complete operation thereof; and further,
- (b) To engage in any artistic, commercial, industrial, and educational enterprise calculated or designed to be profitable to this corporation.
- (c) To generally engage in, do and perform, any enterprise, act, or vocation that a natural person might or could do or perform;


