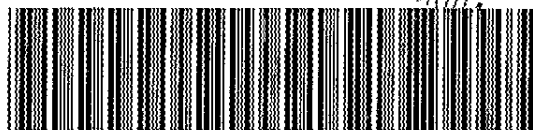




Amendments
