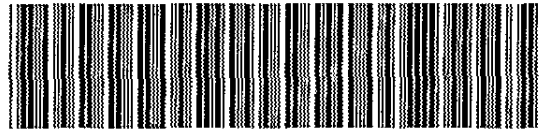

ARTICLE IV


This corporation shall have perpetual existence, unless dissolved in a manner provided by law.
