OF

ARTICLE I - NAME

The name of this corporation is East Side Auto Corp., located at 1042 East 43rd Street, Hialeah, FL 33013.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and the State of Florida.
