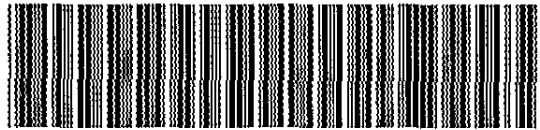

Article VIII Registered Agent

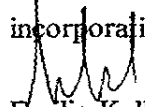

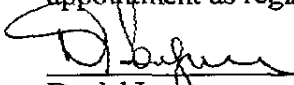
