**FIRST:** The name of the corporation as currently filed with the Florida Department of State is Mango House Corporation.


**SECOND:** The document number of the corporation is P03000065444.


**THIRD:** The date the Articles of Incorporation were filed with the Florida Department of State is June 12, 2003.
