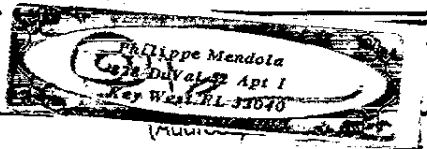

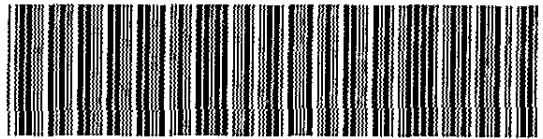

**ARTICLES OF INCORPORATION
OF

ARTICLE I: NAME

The name of the corporation is: Shades "R" Us, Inc.



ARTICLE X: AMENDMENT



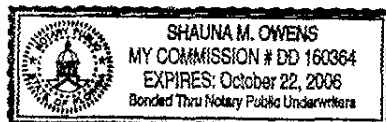


