The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE - NAME

The name of the Corporation is **PRECISE APPRAISALS STATEWIDE**, INC. Its business location shall be 405 Waymont Court, #121, Lake Mary, Florida 32746.
