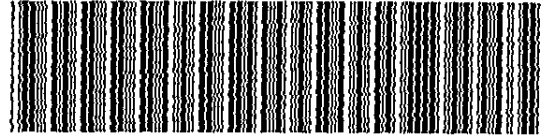

ARTICLES OF INCORPORATION
OF

(a nonprofit corporation)

ARTICLE I
NAME

The name of this corporation is: Safety First For Florida's Children, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 1645 Palm Beach Lakes Blvd., Suite 250, West Palm Beach, Florida 33401.

ARTICLE III
PURPOSE

To engage in the advocacy of safety for Florida's Children and in all lawful acts related to safety.

ARTICLE IV
ELECTION OF DIRECTORS

The corporation initially shall have three directors appointed by the Incorporator. Thereafter, the number of directors may be increased from time to time according to the By-Laws but never shall be less than three. Directors shall be elected by the members of the corporation at the annual meeting of the members of the corporation.

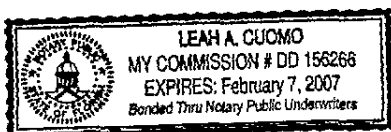


