ARTICLES OF INCORPORATION

OF

The undersigned incorporator files these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I. CORPORATE NAME

The name of this corporation shall be Southeastern Municipal Services, Inc.
