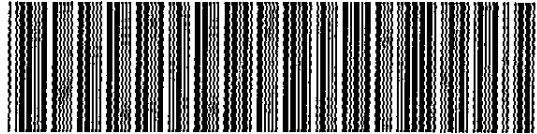



**ARTICLES OF INCORPORATION
OF
A.I. RESEARCH ENTERPRISES, INC.**

The undersigned, acting as incorporator of this corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is: A.I. RESEARCH ENTERPRISES, INC.

ARTICLE II - ADDRESS

ARTICLE III - DURATION

This corporation shall have a perpetual existence.

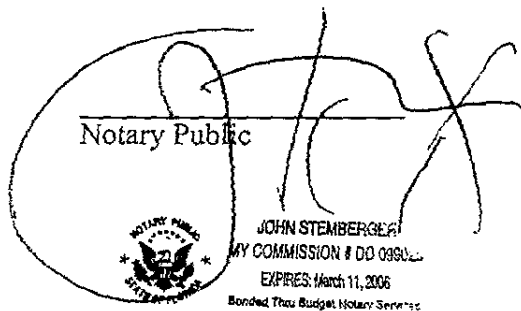
