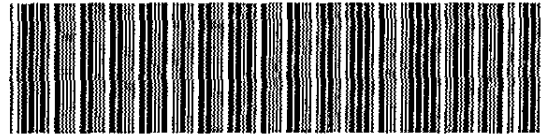

ARTICLE I. NAME


