ARTICLES OF INCORPORATION

OF SURGICHIP, INC.

I, the undersigned Incorporator and Subscriber, being a natural person competent to contract, hereby organize and incorporate under the laws of the State of Florida a corporation for profit as follows:

ARTICLE I - Name of Corporation

The name of this Corporation shall be SURGICHIP, INC.

ARTICLE II - Principal Address

The principal address of this Corporation shall be:

estate or other property, or labor or services actually performed for the corporation at a just

valuation to be fixed by the Board of Directors at a meeting called for that purpose.

ARTICLE VI - Preemptive Rights

Every shareholder, upon the sale for cash or other property of any previously unissued

stock of this Corporation of the same kind, class or series as that which he already holds, shall

have the right to purchase his pro rata share thereof (as nearly as may be done without issuance

of fractional shares) at the price at which it is offered to others.
