OF

The undersigned subscribers as to these Articles of Incorporation, natural persons competent to contract, hereby subscribe to and form a corporation under the laws of the State of Florida. $\Rightarrow \bowtie$

ARTICLE I - NAME

The name of the corporation is BUNCH CONSTRUCTION COMPANY.

ARTICLE II - PURPOSE

The purpose(s) for which the Corporation is organized are:

(a) To engage in all lawful business activities permitted under the laws of the United States and the State of Florida.
