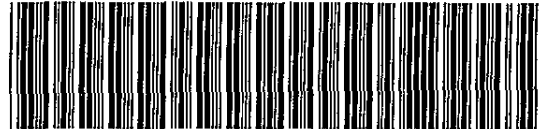

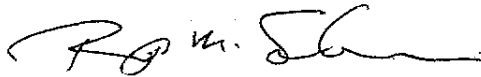

The name of the Corporation ("Corporation") is TDSL Enterprises, Inc..

**ARTICLE II**

The existence of the Corporation shall begin on June 1, 2003.
