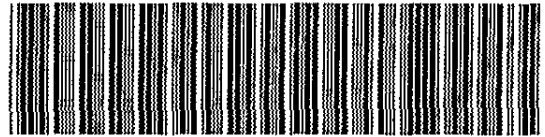

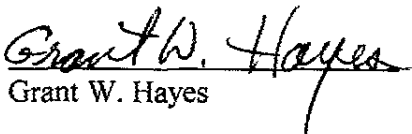
6. Existence.

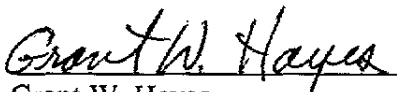
