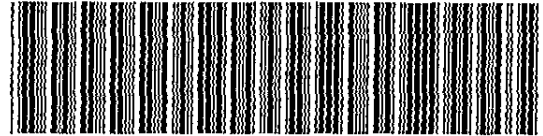

ARTICLE I - NAME

The name of this Corporation is Q.P.C. INC.




