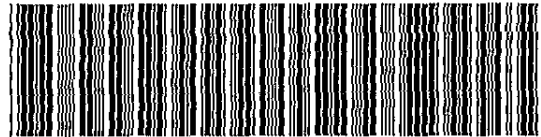

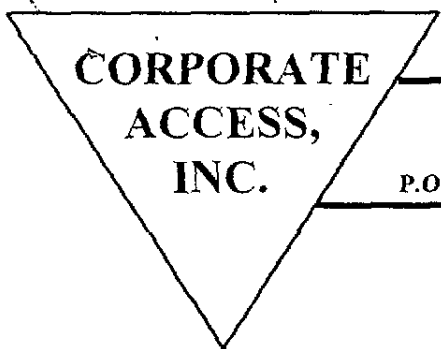

THE UNDERSIGNED incorporator hereby forms a Professional Association under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

HARVEY HOROWITZ, C.P.A., P.A.

ARTICLE II. PRINCIPAL OFFICE

The address of the principal office of this Corporation shall be 1503 Cayman Way, Ste A-4, Coconut Creek, Florida 33066-1434, and the mailing address of the Corporation shall be the same.

ARTICLE III. PURPOSE

This corporation is organized for the following purposes:

A. To engage in the practice of accounting as a professional corporation.

B.
