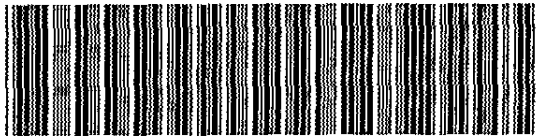

ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator, of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of this corporation shall be RICHARD A. BORES INVESTMENT ADVISORS, INC.

ARTICLE II - PRINCIPAL OFFICE

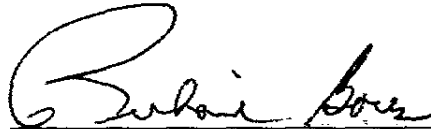
ARTICLE IX - PRE-EMPTIVE

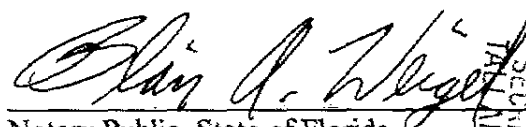
