STATE OF FLORIDA ARTICLES OF INCORPORATION

OF

THE SHELBY GROUP, INC.

FIRST The name of this corporation is The Shelby Group, Inc.

SECOND. Its registered office in the State Of Florida is to be located at 13530 San Rafael Drive, Largo, Florida 33774, County of Pinellas. The registered agent in charge thereof is Gary W. Kuester, 13530 San Rafael Drive, Largo, Florida 33774.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted, and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.
