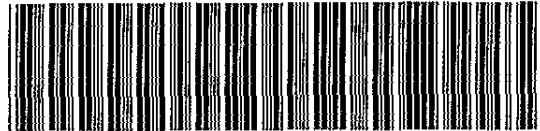

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Home & Garden Lifestyles, Inc.

ARTICLE II - PRINCIPAL OFFICE
