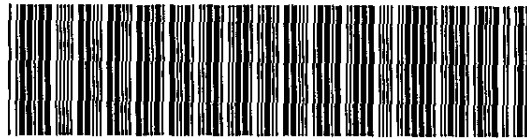

The articles of incorporation of DISCOVER HOME INSPECTIONS, INC. were amended by the corporation's board of directors on April 14, 2005. The corporation is filing these articles of amendment to articles of incorporation pursuant to F.S. 607.0602.

1. The name of the corporation is Discover Home Inspections, Inc.

2. Article I of the articles of incorporation of Discover Home Inspections, Inc. was amended as follows:

"The name of the corporation is Anchor Erosion Control, Inc."

3. Article III of the articles of incorporation of Discover Home Inspections, Inc. was amended as follows:

"The purpose for which this corporation is organized is the conduct of any and all lawful business."

4. Article IV of the articles of incorporation of Discover Home Inspections, Inc. was amended as follows:

"The maximum number of shares this Corporation is authorized to issue is 500, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote."

5. Article VIII of the articles of incorporation of Discover Home Inspections, Inc. was added as follows:

"The shareholders of the corporation shall have preemptive rights."

6. The foregoing amendments to articles of incorporation were duly adopted by the board of directors on April 14, 2005 and by the sole shareholder.
