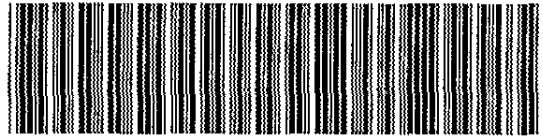

AMENDMENT :**


