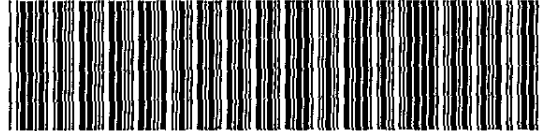

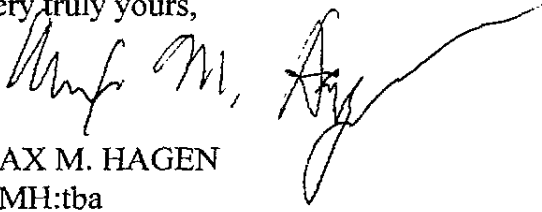

ARTICLE I

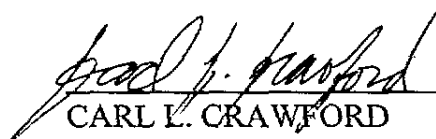
CORPORATE NAME

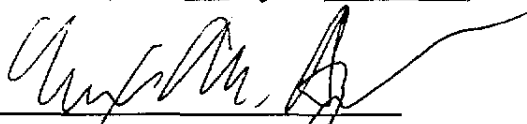
