FOR

CKMS INC.

ARTICLE ONE

The name of the corporation is CKMS INC.

The period of its duration is perpetual.

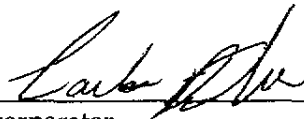

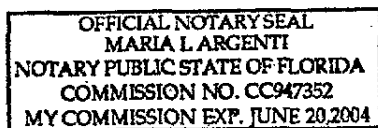


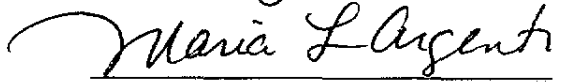
