DURATION:

The Corporation shall have perpetual existence.

The total number of shares authorized shall be one thousand (1000) with a par value of \$1.00.

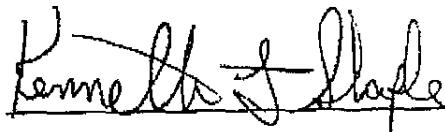

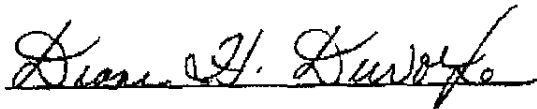

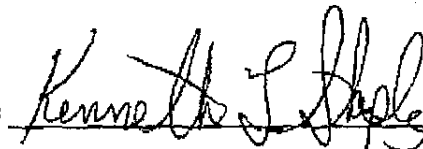
