
ARTICLE THIRTEEN



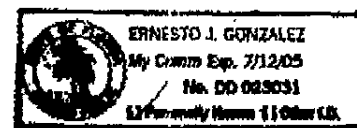
