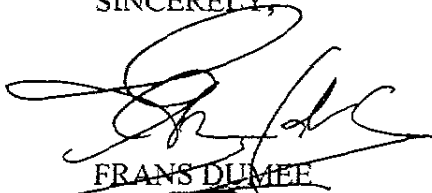

The undersigned, a natural person of the age of sixty four (64) years, acting as incorporator of the corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

**ARTICLE SEVEN**

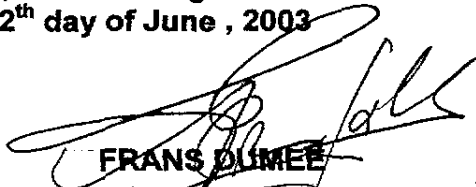

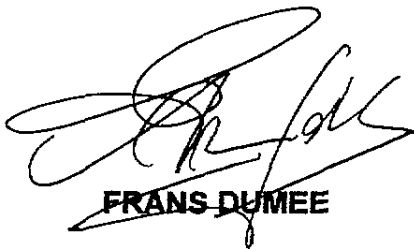
