ARTICLE I
Name

Duration

This Corporation shall have perpetual existence.

ARTICLE III
Purpose

The object and purpose of the corporation and the general nature of the business or businesses to be transacted by it shall be as follows:

3. 4. In general, this corporation shall have and exercise all the powers conferred by the Laws of the State of Florida upon Corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

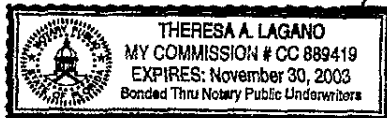


